




KEY HIGHLIGHTS

- Announced M&A with any Irish involvement reached US\$21.4 billion during the first six months of 2024, more than four-times the value recorded during the same period in 2023 and the highest first half total since 2021. The number of Irish deals declined 30% year-on-year to the lowest first half total since 2020.
- Deals involving an Irish target totalled US\$17.7 billion during the first half of 2024, a six-year high, driven by inbound deals which accounted for 93% of activity by value.
- Irish outbound M&A totalled US\$1.1 billion during the first six months of 2024, more than double the value recorded during the same period in 2023 despite a 23% decline in the number of deals.
- In June, Apollo Global Management led an US\$11.2 billion investment for a 49% interest in a joint venture entity related to Intel's semiconductor fabrication plant in Ireland. The deal is the largest with Irish involvement so far during 2024. With it, technology is the most targeted sector in Ireland by value so far this year, accounting for 84% of overall activity.
- Goldman Sachs took the top spot in the financial advisor ranking for M&A with any Irish involvement during the first half of 2024.




IRISH INBOUND M&A BY ACQUIROR ULTIMATE PARENT NATION, YTD (US\$ MIL)


