



# IRELAND: Mergers & Acquisitions, First Half 2022

### Irish involvement M&A declines 71% from last year's first half total; Irish target M&A value declines 35% YTD, despite record number of deals


- M&A with any Irish involvement reached US\$21.6 billion during the first six months of 2022, down 71% from last year which saw the second highest first half total since our records began in 1980. While down compared to 2021, this year's first half total exceeds the value recorded during the first half of each of the previous two years.
- A total of 289 deals with Irish involvement were announced during the first six months of 2022, a figure only exceeded once d uring any first half since our records began in 1980.
- Irish auto technology firm Aptiv agreed to acquire Californian software developer Wind River Systems for US\$4.3 billion in Ja nuary, the largest deal with Irish involvement so far during 2022, boosting Irish outbound M&A to US\$9.5 billion. The largest deal involving an Irish target was a US\$1.6 billion bid from Japan's SMBC Aviation Capital to buy the commercial aircraft leasing business of Dublin-based Goshawk Aviation.
- Deals worth US\$7.9 billion involved an Irish target, 35% less than the value recorded during the same period in 2021 although higher than each of the previous two years. The number of deals increased 4% compared to last year to an all-time record first half tally of 187. Inbound M&A involving a foreign buyer reached US\$7.3 billion, while domestic deals totalled US\$612.8 million.
- Goldman Sachs took first place in the financial advisor ranking for M&A with any Irish involvement during 1H 2022.





#### Announced Irish Inbound M&A by Acquiror Nation, 1H 2022






Announced Any Irish Involvement M&A Advisor Ranking, 1H 2022
